## **Google Analytics**

Our website employs Google Analytics, a Google Inc. web analysis service. For the deactivation of Google Analytics, Google provides a browser plug-in possibility under <http://tools.google.com/dlpage/gaoptout?hl=de>. Google Analytics uses cookies, which are small text files that facilitate the storage of specific information relating to the user contained on the user's browser. The cookies enable Google to carry out an analysis of the use of our website offers. As a rule, the information contained in the cookies relating to the utilisation of our pages (including your IP address) is transferred in anonymised form to a server in the USA where it then stored. Owing to this anonymisation, no conclusions can be drawn concerning your identity. Google observes the data protection regulations of the Privacy Shield Agreement, is registered in the US Department of Commerce's programme of the same name and employs the information gathered in order to evaluate the use of our website, prepare related reports for our use and also provide other services. ## Cookie guidelines

## Server data

For technical reasons, amongst other data, the following information that your Internet browser sends us, or is transferred to our web space provider is stored in so-called server log files:

- Browser type and version
- Operating system

- Date and time of your access
- Your Internet protocol (IP) address.

This anonymous data is stored separately from the personal data that you may have eventually provided and therefore allows no connections to a specific personage.

## External services: Facebook plug-in

Plug-ins of the Facebook social network, 1601 South California Avenue, Palo Alto, CA 94304, USA are integrated into our website pages. The Facebook plug-ins on our pages are recognisable through the Facebook logo, or the like button. If you visit our website, a direct link is established between your browser and the Facebook server via the plug-in. Facebook therewith receives information that you have visited our pages with your IP address. As a result, Facebook is able to allocate the visit to our website to your user account. We wish to point out that as the website controller, we have no knowledge of the transferred data, nor its use by Facebook.
